The majority of staff who work in healthcare and nursing accept that it is a privilege to be able to care for the most vulnerable in our society. For many of us in Nazareth Care Ireland we view our roles as a vocation and have dedicated our lives to caring and protecting others. As healthcare has evolved over the past 50 years the fundamental principles that we uphold have not changed and the values of providing compassionate and respectful personalised care underpin everything that we do.

If you analyse healthcare systems throughout the world and their objectives you will find that many organisations have come to a realisation that effective safeguarding requires that services need to be provided through a person centred model of care in a collaborative way with shared responsibility between the service users, their families and carers, health and social care professionals, service organisations and society as a whole. We as leaders will determine and shape the collaborative culture within Nazareth Care Ireland by how we interact with others and influence people.


Key to the successful safeguarding of vulnerable persons, is an open culture with a genuinely person-centred approach to care/support, underpinned by a zero-tolerance policy towards abuse and neglect. It is important that we create and nurture an open culture where people can feel safe to raise concerns. The importance of good leadership and modelling of good practice is essential in determining the culture of services we provide.

As Chief Nursing Officer for Nazareth Care Ireland, I accept that what is developed today will shape the future and the care that we provide in a society that will judge us on how we treat our most vulnerable members. I ask that all staff reflect on the thought that if you have followers, then you are a leader. Going forward our leaders must be inspirational and visionary.

My key objectives for Nazareth Care Ireland are to ensure that we deliver a model of care that is exemplary and sets standards for best practice. If we deliver a model of best practice, we will not create or allow abuse to fester. Therefore, we have to continually explore, transform and evaluate our systems to achieve a model of best practice.

Victoire Larmenier: Spirit and Vision

This is a biography of Victoire Larmenier, (1827—1878). Foundress of the Congregation of the Sisters of Nazareth It depicts her courage, daring, self-sacrifice, extraordinary commitment and passionate response to those in need.

Amidst the elite of London in those days, there were extremes of poverty where the underprivileged lived and died on the streets and their children begged and worked. These were the people Victoire Larmenier and her Sisters came to help.....

Message from Safeguarding Committee

The safeguarding committee would like to take this opportunity to acknowledge the wonderful work that Mr. Roshy P. Antony as Designated Liaison Person and his Deputy Sr. Victoire Mulligan have done since the committee was first established. The committee also recognise the importance of safeguarding being kept to the fore in the day to day running of every house and to this end we congratulate Roshy and Sr Victoire on the production of attractive and easily accessible safeguarding pamphlets and posters.

The committee at our last meeting discussed and approved the need to incorporate care of vulnerable adults into our policies whilst always being vigilant regarding the safeguarding of children. We discussed at length and saw the implementation of policies regarding the safe use of computers in order to ensure that they are all password controlled as being vitally important. The committee also agreed the education of transition year students as to the ethos of Nazareth care at the start of their volunteering work experience to be essential.

The committee views the development whereby Roshy became the in-house trainer for all the houses to be excellent as he knows and understands the ethos of the Nazareth community. His appointment means there is continuity in the training provided plus his training sessions can be tailored to meet the needs of particular houses. With the passage of time he is developing relationships with the managers and staff in each house.


Our next meeting is planned for Thursday June 28th in Sligo in line with our plans to visit all houses. Our visit to Mallow last year was very successful.
